MF Global Holdings USA Inc. (the "<u>Debtor</u>") has filed its voluntary petition (the "<u>Petition</u>") for relief under title 11 of the United States Code, 11 U.S.C. §§ 101-1330, as amended (the "<u>Bankruptcy Code</u>"), in the United States Bankruptcy Court for the Southern District of New York.

In addition, on October 31, 2011, two affiliated entities, MF Global Holdings Ltd. and MF Global Finance USA Inc. (the "<u>Initial Debtors</u>") filed petitions for reorganization pursuant to chapter 11 of the Bankruptcy Code. On November 2, 2011, the Court entered an order authorizing the joint administration of these two separate chapter 11 cases (case numbers 11-15058 and 11-15059) for procedural purposes only under case number 11-15059. On December 19, 2011, three additional affiliated entities, MF Global Capital LLC, MF Global Market Services LLC and MF Global FX Clear LLC (collectively, the "<u>Additional Debtors</u>" and together with the Initial Debtors, the "<u>Prior Debtors</u>"), filed petitions for reorganization pursuant to chapter 11 of the Bankruptcy Code. On December 21, 2011, the Court entered an order authorizing the joint administration of the Additional Debtors' separate chapter 11 cases (case numbers 11-15808, 11-15809, and 11-15810) with the Initial Debtors for procedural purposes only under case number 11-15059.

Contemporaneous with the filing of its Petition, the Debtor will file a motion seeking to have its case jointly administered with the chapter 11 cases of the Prior Debtors.
