Defendants-Appellants, Iron-Starr Excess Agency Ltd., Ironshore Insurance Ltd., and  
Starr Insurance & Reinsurance Limited (collectively “the Iron-Starr Insurers”)<sup>1</sup> files this

<sup>1</sup> Pursuant to Fed. R. Bankr. P. 7012(b), the Iron-Starr Defendants do not consent to the entry of final orders or judgment by the bankruptcy judge in this matter. See Wellness Int’l Network, Ltd. v. Sharif, No. 13-935, 135 S.Ct. 1932, 1937 (May 26, 2015) (holding that parties may consent to a bankruptcy court’s constitutional jurisdiction, but that consent must be knowing and voluntary).

Designation of Record pursuant to Rule 8009 of the Federal Rules of Bankruptcy Procedure with respect to their appeal dated February 6, 2017, from the following orders and opinions: (1) the oral ruling of the United States Bankruptcy Court for the Southern District of New York (Hon. M. Glenn) (the “Bankruptcy Court”) on January 23, 2017, finding that the Iron-Starr Insurers violated the Barton doctrine and ordering the relief that the Iron-Starr Insurers dismiss “the Bermuda proceedings against the plaintiffs and to cease any further proceedings against the plaintiffs in any Court other than this Court” (Jan. 23, 2017 Hr’g Tr. 114:12-17); (2) the Bankruptcy Court’s January 23, 2017 written Order Finding that the Bermuda Insurers Violated the Barton Doctrine and Ordering Relief (attached hereto as Exhibit B); and (3) the Bankruptcy Court’s January 31, 2017 Memorandum Opinion and Order Finding that the Bermuda Insurers Violated the Barton (collectively the “Barton Orders”).
